


# Rapid Information assessments – 'trendspotter studies' - role in drug monitoring

- Rapid and in-depth information gathering
- On subject of concernuments
  uncertainty
- One off and ad hoc

- Electronic surveys
- Expert presentations

- Social media


#### Mixed methods




#### Convergent Mixed Methods Design

#### Trendspotter study process







#### **IDM** study objectives


To increase understanding of the **online supply of drugs** and undertake a mapping of the **range of internet drug markets** in existence.

- Sale of drugs on the deep web







# Limitations of the approach



- Scarcity of data
- Dependent on weak data
- Reliant on quality of experts
- One off snapshot
- Spotlight, but not repeated

### Strengths

- Fill knowledge gaps
- Benefit of timeliness and sensitivity
- Rich analysis multi dimensional
- Can address quantitative issues - how many, where, when?
- Also qualitative issues how, what?



# TS role in drug monitoring

- Complementary to monitoring
- Explore an issue raised by monitoring
- Incorporates monitoring data
- In depth exploration of a topic
- Adds a qualitative, human component
